- Assist in supervising the responsibilities, duties and activities of AIN's
- Document accurately, and write reports compliant with aged care documentation standards, ACFI and other professional requirements.
- Utilise resources effectively, efficiently and appropriately.
- Report concerns, issues and enquiries to the Registered Nurse.
- Use sound judgement in identifying situations requiring the assistance of a Registered Nurse.
- Participate in case conferences of residents with the health team and families

## The key responsibilities related to teamwork are to:

- Liaise in a positive way with team members, families and other health professionals to ensure co-ordination of care for optimum resident outcomes.
- Comply with Cabanda Care's policies and procedures; information systems, relevant legislative, professional quality standards.
- Participate in Cabanda Care's Continuous Quality Improvement (CQI) activities.
- Undertake both annual mandatory and elective training as required.
- Demonstrate competency of practice.

#### The key responsibilities related to Occupational Health and Safety are to:

- Adhere to Cabanda's infection control policies and procedures.
- Comply with Workplace Health and Safety and Environmental practices.
